## **INTERNAL AUDIT NORMS**

### **I. EMPANELMENT**

The panel of auditors based on the eligibility criteria may be prepared by inviting application from the interested CA firms through SIPCOT website.

### **II. ELIGIBILITY CRITERIA**

1. CA firm should have registered with the Institute of CA's of India.
2. The firm should be in existence for at least 5 years.
3. The firms should have minimum 3 qualified CAs and of which at least one should be FCA.
4. The firm shall have its Office at any one of the cities mentioned in the list.
5. The firm should have empanelled for Bank audit and CAG audit.
6. The firm should have conducted Bank audit –( statutory branch audit / concurrent audit / revenue audit) for a minimum period of 5 years.
7. The firm should have conducted Government / Public Sector Undertaking Audits for at least 5 years.

Selection Committee may relax certain conditions if suitable firms with all criteria is not available for selection in respect of any of the complex or to select from next nearest city.

### **III. SELECTION OF AUDITORS**

From the Panel of auditors, the auditors to be appointed for each Project Office / Head Office shall be selected by the Complex Auditors Selection Committee (CASC)

to be chaired by PS/CMD and members consisting of GMs, Heads of Finance and Internal Audit Departments.

#### IV. SCOPE OF AUDIT

Regular audit of all receipts and payments of the Project Office / Head Office audit of all accounting records, registers. Verification and certification of Trial Balances and schedules with concerned ledgers.

In respect of Project Office, Stock of land as on 31<sup>st</sup> March indicating Plot No./ Acre is also to be certified.

VI. TERMS AND CONDITIONS:

The last date of submission of application is 31.8.2019.

The selected CA firms will be appointed initially for a period of one year which will be extendable by another year if their services are found satisfactory on mutually agreed terms and conditions.

The audit team should be headed by qualified CA. The audit shall be conducted for every half year of the Financial Year. For the first half year of 2019-20, it should be completed before 15<sup>th</sup> January 2020 and second half year of 2019-20, it should be completed before 15<sup>th</sup> June 2020.
